



## ScreenGuard window and door end-user promotion - Terms and Conditions

2. The promoter of this Promotion is Darley Aluminium Trading Pty Ltd ACN 076 364 657 of 8 Tyrone Place, Erskine Park NSW 2759 ('Darley').
3. This Promotion is only open to Australian resident individuals 18 years or over.
4. Darley employees and their immediate families are ineligible to participate in the Promotion.
5. The end user will gain entry into the draw when they submit at least one photo and proof of purchase via the online form of a ScreenGuard stainless steel mesh security system (as listed in point 7.) that is installed at their premises during the promotional period.
6. Proof of purchase can be in the form of a tax invoice or receipt. Darley will make contact with the Security fabricator nominated on the online form to verify the job.

The above-mentioned ScreenGuard stainless steel mesh security system is limited to the following products; Hinged door, sliding door, window screen, multi-fold door (ScreenFold), patio enclosure, and ScreenGuard access fire escape. The ScreenGuard system installed must contain ScreenGuard aluminium frame, ScreenGuard stainless steel mesh and be purchased from a licensed ScreenGuard Fabricator.
8. Entry into the draw may consist of images of multiple ScreenGuard products but will be limited to one prize per premises.
9. Each prize will be the value of the ScreenGuard stainless steel security system installed at the premises, with the value not exceeding \$1,500 ex GST. Winners will be asked to specify a bank account for the funds to be transferred.
